## 1. INTRODUCTION


Close fitting gloves suitable for professional workshop use. Palm is padded with cushion points giving added protection against vibration, ideal for use with air or electric power tools. Extra protection between the index finger and thumb to protect the hand. Hook-and-loop wrist strap. Large/Extra-Large Sizes.

The gloves shall not be worn when there is a risk of entanglement by moving parts of machines.
